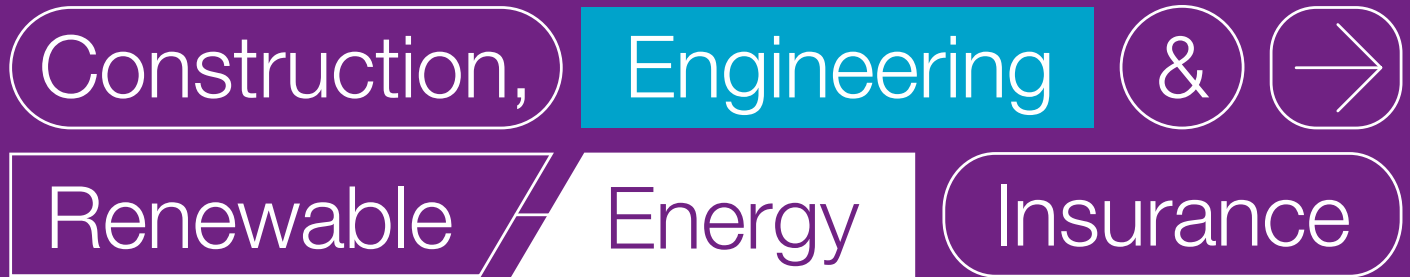

Erection All Risks

Short Term Operating Reserve (STOR)

Utility scale (>500kW) commercial installations meeting RSA risk control standards.



Battery Energy Storage Systems (BESS)

Utility scale (>500kW) commercial installations meeting RSA risk control standards.
